*Mr. Sloan states that an official plat must be provided in order to split parcels of land*

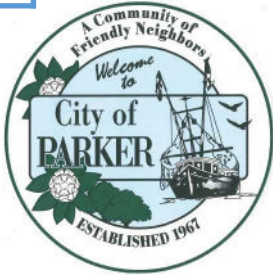
*Chairman Rega presents the rules and processes for Parker as well as Bay County*
