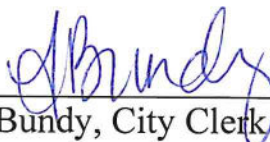

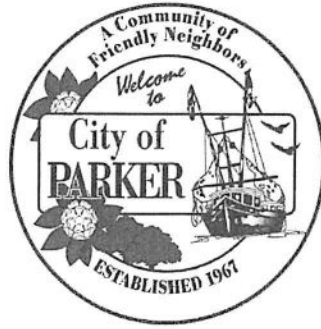

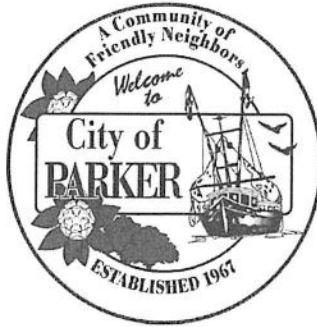

With no further discussion the meeting adjourned at 5:03 P.M.

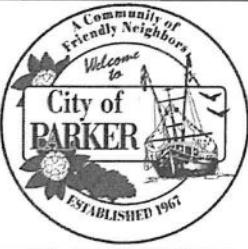

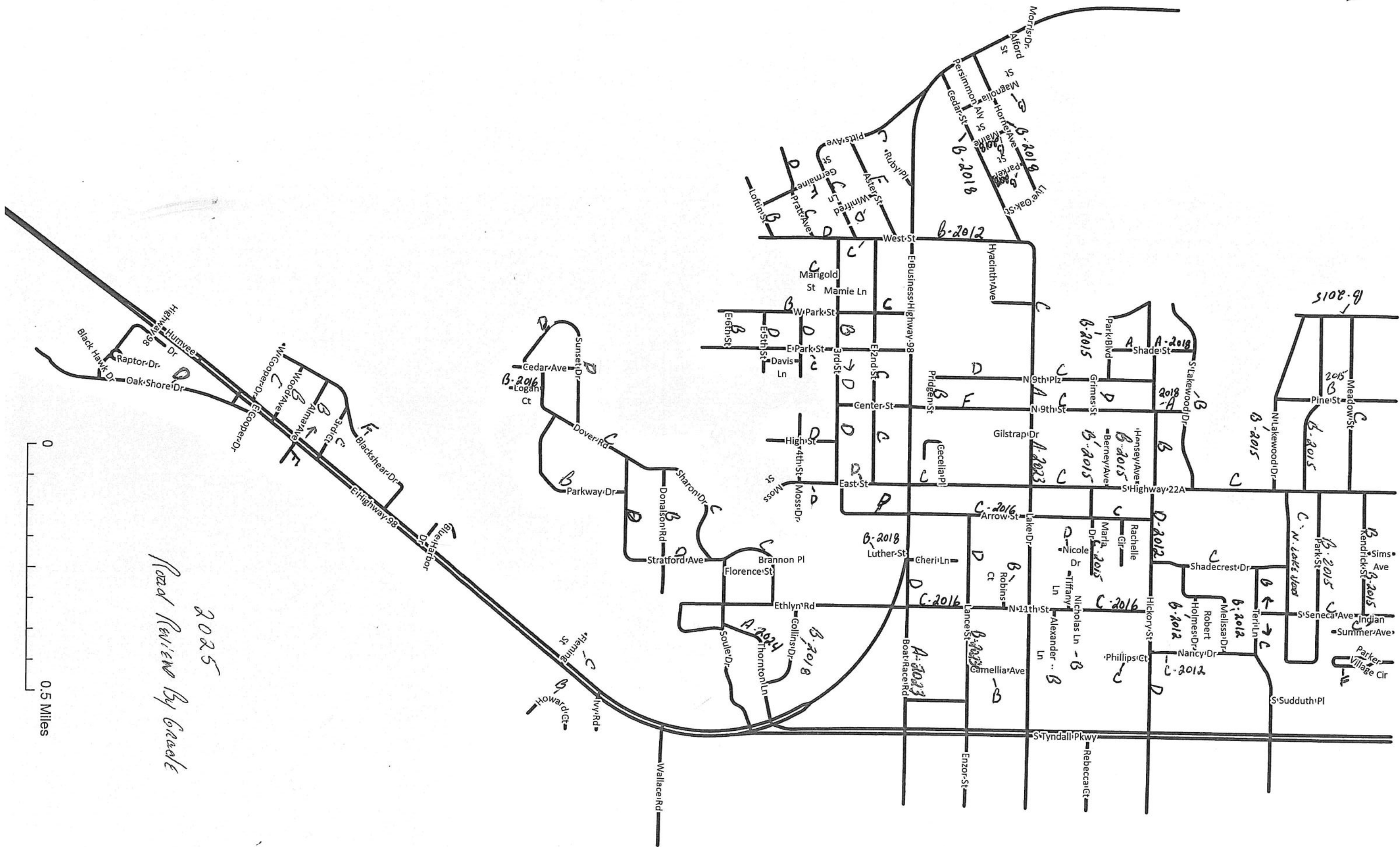
