Any requests for a subpoena for a witness must be made to the City Clerk at least 7 days in advance of the proceeding. If the owner of the property (or their designee) or a witness not under a subpoena fails to attend the relevant proceedings, the Magistrate may decide the case without the benefit of testimony or evidence that is not presented.
