

RESOLUTION NO. 36

WHEREAS, by resolution dated October 5, 1971, the Board of County Commissioners, Bay County, Florida, requested that each municipality within the County provide the Board of County Commissioners with a priority listing of all road projects for which County cooperation is requested,

BE IT THEREFORE RESOLVED that the City of Parker hereby designates the following priority for accomplishment of road projects with County assistance and cooperation:
