WHEREAS, the Parker City Council has recognized the traffic problem of U.S. Highway 23l joining Dothan, Alabama, with the Florida cities of Campbellton, Cottondale, Alford and the 90,000 people of Bay County; and

WHEREAS, a thirty-two (32) mile stretch of U.S. Highway 231 is still a two-lane highway and should be four-laned without delay.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Parker, Florida, that we fully support the joint Resolution of Bay County Chamber of Commerce and the Traffic and Transportation Club of Panama City, Inc., dated 14 July 1977, and signed by presidents Rayford L. Lloyd, Jr., and D. P. Clark of each respective organization above; that

(1) A copy of this resolution be forwarded to Governor Reubin Askew, Senators Dempsey Barron and Pat Thomas; Representatives Earl Hutto, Billy Joe Rish, and Wayne Mixson; Congressman Bob Sikes and Don Fuqua; and a copy to Tom Webb, Transportation Secretary.

#### JOINT RESOLUTION

WHEREAS the Bay County Chamber of Commerce, joined by the Traffic and Transportation Club of Panama City, Inc., have become convinced that urgent action is demanded by the serious inadequacy of, and the growing safety hazards created by, the two-lane condition of U.S. Highway 231; and

WHEREAS U.S. Highway 231 is the major highway artery joining Dothan, Alabama (and points north) with the Florida cities of Campbellton, Cotton-dale, Alford and the 90,000 people of Bay County; and

WHEREAS a thirty-two (32) mile stretch of U.S. Highway 231 is still a two-lane highway, on which:

- (a) An average of 2.8 persons have been killed each year during the past five years1;
- (b) An average of 90.8 traffic accidents have occurred each year during the past five years<sup>2</sup>;
- (c) An average of \$566,760.00 in property damage has occurred each year during the past five years<sup>3</sup>;
- (d) 1,113 children travel over U.S. Highway 231, on school days in Bay County, in 21 school buses traveling twice daily, making a total of 210 trips weekly<sup>4</sup>;
- (e) 720 children travel over U.S. Highway 231, on school buses in Jackson County, in 12 school buses traveling twice daily, making a total of 120 trips weekly<sup>5</sup>;
- (f) Tourists annually spend \$75 million during the summer (measured by retail sales) in Bay County, and \$7 million during the winter months (again measured by retail sales), and 91% of these tourists arrive by automobile 6;
- (g) 9,900 truck trips by Great Southern Paper Company alone occur annually over U.S. Highway 231 between Alford and Fountain, emphasizing the role of U.S. Highway 231 as a commercial artery7; in addition, trucking companies using U.S. Highway 231 on at least a daily or weekly basis include McKenzie, Motor Fuel Carriers, P.C. White, Florida Rock, Ryder, Howard Hall, M.R.&R., Mercury, Sunshine-Jr. Foods, Standard Oil, Starling Oil, and International Paper Co.

NOW THEREFORE BE IT RESOLVED by the Bay County Chamber of Commerce, joined by the Traffic and Transportation Club of Panama City, Inc., that:

- The critically impacted two-lane portion of U.S. Highway
   231 must be four-laned immediately, without further delay;
   and
- (2) The County Commissioners of Jackson and Bay Counties; the City Commissioners of Campbellton, Cottondale, Alford, and Panama City; the Jackson County Chamber of Commerce; all all other interested public officials, organizations and individuals; are invited to join with us in moving forward now; and

- (3) Senators Dempsey Barron and Pat Thomas, and Reps. Earl Hutto, Billy Joe Rish, and Wayne Mixson are requested to give this matter the highest priority, including an early joint meeting with Gov. Reubin Askew and Transportation Secretary, Tom Webb; and
- (4) Gov. Reubin Askew is requested to assist in reordering priorities in the Florida Department of Transportation, to enable the immediate completion of the construction on the hazardous 32 miles of two-lane of U.S. Highway 231; and
- (5) Congressman Bob Sikes and Don Fuqua are requested to obtain from the U.S. Department of Transportation a report stating what must be done now to move this project off "dead center."
