

RESOLUTION NO. 64

WHEREAS, the City Council of Parker, representing the citizens of Parker, of Bay County, have been apprised by the Transportation Committee of the acute problem concerning the adequacy of airline transportation into the Panama City area, and

WHEREAS, the City Council has been informed that the airline Air Florida, has petitioned the State of Florida Public Service Commission their desire for the Public Service Commission to grant Air Florida permission to commence airline transportation between the points: Tampa, Panama City, and Pensacola, Florida, now therefore

BE IT RESOLVED by the unanimous vote of the City Council of Parker, Florida as follows:

1. The Council urges the State of Florida Public Service Commission to place Air Florida's petition for airline transportation service between Tampa, Panama City and Pensacola on their agenda for hearing at their earliest possible date.

2. The Council urges the State of Florida Public Service Commission to act favorably on the petition of Air Florida in order that service to the Panama City area may commence as soon as possible.

BE IT FURTHER RESOLVED that copies of this resolution be transmitted to National Airlines, Southern Airlines, Panhandle Airways, Bay County Commission, the City of Callaway, the City of Cedar Grove, the City of Lynn Haven, the City of Mexico Beach, the City of Panama City, the City of Panama City Beach, the City of Springfield, State Senator Dempsey Barron, State Representatives Billy Joe Rish and Earl Hutto and Congressman Robert F. Sikes, with a request that these persons aid us with their support of this Resolution.
