WHEREAS, a portion of the real property involved and necessary to the Project is owned by the City of Parker; and

WHEREAS, the Department of Transportation has made a request for a perpetual easement on certain real property in connection with the Project.

NOW, THEREFORE, it is resolved that:

The City Council authorizes and directs the Mayor and City Clerk to execute any and all necessary instruments to grant the State of Florida, for the use and benefit of the State of Florida Department of Transportation, a perpetual easement to be used solely in connection with the Project over the certain real property located and situated in Parker, Bay County, Florida, to wit:

In Section 24, Township 4 South, Range 14 West, BEGIN at a point 10.0 feet East of the Northwest Corner of Lot 5, according to the Map of Parker recorded at Plat Book 5, Page 2, in the Official Records of Bay County, Florida; thence East 10.0 feet; thence South 15.0 feet; thence West 10.0 feet; thence North 15.0 feet to the POINT OF BEGINNING.

EASEMENT

THIS EASEMENT ("Easement") is entered into this 6th day of December, 1988, by and between the State of Florida, for the use and benefit of the State of Florida Department of Transportation, 605 Suwannee Street, Tallahassee, Florida 32301 ("DOT") and the City of Parker, Florida, a municipal corporation ("Parker").

For and in consideration of Ten and No/100 Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Parker hereby grants to DOT, its successors and assigns, a non-exclusive easement under the terms and conditions herein over, upon, and on to the following described real property located and situated in Parker, Bay County, Florida, to wit:

In Section 24, Township 4 South, Range 14 West, BEGIN at a point 10.0 feet East of the Northwest Corner of Lot 5, according to the Map of Parker recorded at Plat Book 5, Page 2, in the Official Records of Bay County, Florida; thence East 10.0 feet; thence South 15.0 feet; thence West 10.0 feet; thence North 15.0 feet to the POINT OF BEGINNING. ("Property")

for purposes of installation of a power pole, guy wires and anchors, and associated electrical transmission lines running over and across the Property, and all necessary structures and facilities to run utilities to a power pole erected upon the Property ("Project").

- 2. Parker reserves all of its right, title and interest in and to the oil, gas and other minerals in, on, and under the Property.
- 3. This perpetual Easement shall commence on the date of execution of this Easement and shall continue for so long as DOT requires use of the Property for the Project; provided, however, in the event the DOT should abandon the use of the Property in connection with the Project, all of the rights hereby granted shall cease and terminate and all interest in the Easement shall revert to Parker without the necessity for demand or re-entry; and it is intended that such right of reverter shall be in addition to any statutory provision for abandonment contained

under the laws of the State of Florida.

- 4. This Easement shall not be construed in any way to create a conveyance of fee simple title to all or any part of the Property.
- 5. DOT shall not commit waste nor commit or permit any illegal use of the Property.

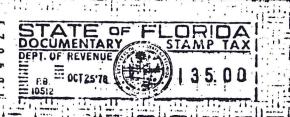

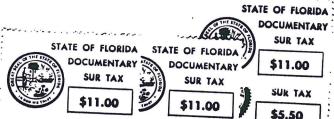
