At the January 20, 1992 meeting of the Council, Commissioner Bill Peebles advised the Council that a Bill was to be introduced to the Florida Legislature by Representative Pruitt which would repeal the Florida Regional Planning Council Act. This would abolish all Regional Planning Councils in the State.

A bill to be entitled

An act relating to regional planning; providing for review and repeal of ss. 186.501-186.515, F.S., the Florida Regional Planning Council Act; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Sections 186.501, 186.502, 186.503, 186.504, 186.505, 186.506, 186.507, 186.508, 186.509, 186.511, 186.513, and 186.515, Florida Statutes, are repealed on October 1, 1993, and shall be reviewed by the Legislature prior to that date.

Section 2. This act shall take effect upon becoming a law.

HOUSE SUMMARY

Provides that the Florida Regional Planning Council Act shall be repealed October 1, 1993, and reviewed by the Legislature prior thereto.
