

RESOLUTION NO. 157

A RESOLUTION OF THE CITY OF PARKER, FLORIDA, SUPPORTING THE DISTRIBUTION OF FEDERAL HAZARD MITIGATION GRANT FUNDS ALLOCATED TO BAY COUNTY FLORIDA AS AGREED BY REPRESENTATIVES OF LOCAL APPLICANTS ASSEMBLED IN A WORKSHOP HELD MAY 29, 1996, AND RECITING AN EFFECTIVE DATE

BE IT RESOLVED by the City Commission of the City of Parker, Florida, that the Florida Department of Community Affairs is urged to promptly distribute the sum of \$8,143,949.53 in Federal Hazard Mitigation Grant funds allocated for applicants located within Bay County, Florida, in the amounts and for the projects shown upon the attached and incorporated Exhibit A, which sub-allocation was agreed upon by representatives of the local applicants in a workshop held May 29, 1996. If requested, the appropriate officers of the City are authorized to enter an agreement between the applicants to facilitate such distribution.
