A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PARKER, FLORIDA, ESTABLISHING DEVELOPMENT ORDER FEES, DEFRAYING THECOST OF THE DEVELOPMENT REVIEW PROCESS, REPEALING RESOLUTION NO. 232 AND RESOLUTIONS IN CONFLICT HEREWITH PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Parker ("City") has previously enacted various regulations including but not limited to Land Development Regulations and sections in the Code of Ordinances of the City governing the development of land and construction of improvements and structures within its limits, and providing for the review and permitting of certain other matters by the City or its designee;

WHEREAS, the City Council may establish and periodically adjust a schedule of fees and charges to defray any direct or indirect costs associated with the foregoing; and

WHEREAS, the City Council desires to set out and adopt a current schedule.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF PARKER:

Section 1. The attached fee schedule is hereby adopted and shall remain in full force and effect until amended or superseded.

Section 2. The descriptions contained in the attached schedule are for illustrative purposes only, and do not 12/28/2012 2012-313

limit or define the type of development order sought, or the subject matter or applicability of the relevant portions of the Code, Ordinances, or Land Development Regulations of the City. To determine the exact nature of any activity governed by a section, or the level of development involved, the relevant section of the Code or Land Development Regulation must be examined.

Section 3. Resolution No. 232 and all other resolutions or parts of resolutions of the City in conflict with the provisions of this Resolution are hereby repealed to the extent of such conflict.

Section 4. If any section, subsection, sentence, clause, phrase, word or provision of this Resolution is for any reason held invalid or unconstitutional by any court of competent jurisdiction, whether for substantive, procedural, or any other reason, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions of this Resolution.

Section 5. This Resolution shall take effect immediately upon its passage.
