A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PARKER, FLORIDA, TO APPROVE HAZARD MITIGATION PROJECT LISTED IN THE BAY COUNTY LOCAL MITIGATION STRATEGY (LMS) PLAN, AS AMENDED, AND APPROVAL OF THE TWENTY-FIVE PERCENT (25%) MATCH FOR THE HAZARD MITIGATION GRANT PROGRAM (HMGP) FUNDING, REPEALING ALL RESOLUTIONS IN CONFLICT HEREWITH AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Parker, Florida ("City") is participating in a hazard mitigation planning process as established under the Disaster Mitigation Act of 2000; and

WHEREAS, the Bay County Local Mitigation Strategy Plan is a multi-jurisdictional hazard mitigation plan which encompasses Bay County, the Cities of Callaway, Lynn Haven, Mexico Beach, Panama City, Panama City Beach, Parker and Springfield; and

WHEREAS, the Bay County LMS Plan is updated on a yearly basis and after any major natural disaster event; and

WHEREAS, Hurricane Michael devastated Bay County and the surrounding area on October 10, 2018; and

WHEREAS, City is submitting project applications to the Federal Emergency Management Agency and the State of Florida for potential grant funding and realizes that a twenty-five percent (25%) grant match must be met for each project; and

WHEREAS, City has identified a funding source for the twentyfive percent (25%) matching funds for the project listed below and
is committed to providing the match through the amounts raised with
the infrastructure sales surtax or in-kind contributions:
