RESOLUTION NO. 2020-373

A RESOLUTION OF THE CITY OF PARKER AUTHORIZING PREPARATION AND SUBMITTAL OF AN APPLICATION FOR FUNDS FROM THE FLORIDA DEPARTMENT OF ECONOMIC OPPORTUNITY FOR FUNDING THROUGH REBUILD FLORIDA HURRICANE MICHAEL COMMUNITY DEVELOPMENT BLOCK GRANT DISASTER RECOVERY GENERAL INFRASTRUCTURE REPAIR PROGRAM AND APPROVING CERTAIN SPECIFIC ITEMS AND NOTICES; PROVIDING FOR SEVERABILITY AND A REPEALER CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Florida Department of Economic Opportunity ("DEO"), has allocated approximately \$111,000,000 in Community Development Block Grant Disaster Recovery ("CDBG-DR") funds available through their Rebuild Florida Hurricane Michael General Infrastructure Repair Program with a minimum award not to be below \$250,000.00;

WHEREAS, regulations governing the CDBG-DR program allow the utilization of said funds to rebuild infrastructure impacted by Hurricane Michael;

WHEREAS, the City of Parker desires to request CDBG-DR funds from the DEO in order to improve the quality of life of Parker citizens; and

WHEREAS, the City of Parker deems it to be in the best interests of the citizens of Parker to mitigate against damaged properties by seeking CDBG-DR funds to serve its citizenry.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PARKER AS FOLLOWS:

SECTION 1. The City of Parker, acting by and through its Mayor, is hereby authorized and directed to submit an application for CDBG-DR funds, and along with said application, all understandings and assurances contained therein and to provide such additional information and sign such other documents as may be required.

 $\underline{\text{SECTION}}$ 2. The City adopts the City of Parker Rebuild Florida General Infrastructure Repair Program and the

City of Parker Citizen Participation Plan, each identified by or in substantially the forms attached hereto as Exhibits "A" and "B", respectively, with such changes as may be approved by the Mayor or Mayor Pro Tem on behalf of the City of Parker. The City Council authorizes the publication of the Notice of Public Hearing of the Community Development Block Grant - Disaster Recovery Program in substantially the form attached hereto as Exhibit "C", with such changes as may be approved by the Mayor or Mayor Pro Tem on behalf of the City of Parker.

 $\underline{\text{SECTION 3}}$. The Mayor is hereby authorized on behalf of the City of Parker to execute a grant offer and any other documents necessary to the acceptance and implementation of the program should the project be approved.

SECTION 4. If any section, subsection, sentence, clause, phrase, word or provision of this Resolution is for any reason held invalid or unconstitutional by any court of competent jurisdiction, whether for substantive, procedural, or any other reason, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions of this Resolution.

 $\underline{\text{SECTION 5}}$. All resolutions or portions thereof of the City of Parker, including in conflict with the provisions of this Resolution are hereby repealed to the extent of such conflict.

 $\underline{\text{SECTION }6}$. This Resolution shall take effect immediately upon its passage.
