1. Second Reading of Ordinance 2017-377—Elections—Council

This ordinance calls for a referendum to amend the City Charter. The referendum question is whether a candidate seeking to run for office should designate which seat he or she is running for, such as Seat 1 or 3, Seat 2 or 4. The referendum is not changing that all candidates run at-large and represent the entire city.

AN ORDINANCE OF THE CITY OF PARKER, FLORIDA, AMENDING THE CODE OF ORDINANCES OF THE CITY OF PARKER (ORDINANCE NO. 2010-349, AS AMENDED); AMENDING CERTAIN PROVISIONS OF THE CITY CHARTER RELATING TO ELECTIONS; REQUIRING QUALIFICATION AND ELECTION BY SEAT FOR CITY COUNCIL; PROVIDING A BALLOT TITLE AND WORDING FOR THE SUBSTANCE OF THE PROPOSED AMENDMENTS; PROVIDING FOR REFERENDUM ELECTION; PROVIDING FOR SEVERABILITY; PROVIDING A MECHANISM FOR THE CORRECTION OF SCRIVENER'S ERRORS; PROVIDING FOR THE LIBERAL CONSTRUCTION OF THIS ORDINANCE; PROVIDING FOR CODIFICATION AND REPEALER CLAUSES; AND PROVIDING FOR AN EFFECTIVE DATE.
