ORDINANCE NO. 2022-397

AN ORDINANCE AMENDING THE COMPREHENSIVE PLAN OF THE CITY OF PARKER, SPECIFICALLY TO ADOPT A PROPERTY RIGHTS ELEMENT; PROVIDING FOR SEVERABILITY; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Chapter 2021-195 of the Laws of Florida requires that local governments amend their Comprehensive Plan to add a Property Rights Element containing certain minimum language (if such an element does not already exist);

WHEREAS, the Planning Commission of the City of Parker ("City") held a public hearing on October 12, 2021, and the City Council of the City held a public hearing on October 19, 2021, to discuss a propose amend the City's 2040 Comprehensive Plan adopted by Ordinance No. 2019-383 to add a Property Rights Element as Section 11;

WHEREAS, the City Council adopted Resolution No. 2021-380 on October 19, 2021, authorizing the transmittal of the proposed Property Rights Element to the appropriate governmental agencies;

WHEREAS, the City has received no comments requesting any changes to the proposed amendment language;

WHEREAS, the City held a public hearings on February 1, 2022, and on February 15, 2022, to consider the attached amendment, with due public notice having been provided, and having reviewed and considered the comments received during the public hearing, and provided for necessary revisions, and approved the proposed amendment for adoption; and,

WHEREAS, in exercise of its authority, the City Council of the City finds it necessary and desirable to adopt and does hereby adopt the attached Comprehensive Plan Amendment.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PARKER AS FOLLOWS:

SECTION 1. Comprehensive Plan Amendment.

The City of Parker Comprehensive Plan is hereby amended as set forth in and incorporated herein by reference, and consists 02/15/2022 1 2022-397

of a City-initiated text amendment to the Index and the addition of Section 11 to the 2040 Comprehensive Plan, a copy of which is attached hereto and made a part hereof.

SECTION 2. Transmission of Ordinance.

The employees and/or consultants of the City are requested and instructed to take the necessary action to transmit this Ordinance and the attached amendment to the required state or federal agencies or bodies.

SECTION 3. Copy on File.

An official, true, and correct copy of all elements of the City of Parker Comprehensive Plan, as adopted and amended from time to time, shall be maintained by the City Clerk or his or her designee.

SECTION 4. Severability.

If any provision or portion of this ordinance is declared by any court of competent jurisdiction to be void, unconstitutional, or unenforceable, then all remaining provisions and portions of this Ordinance and the City's Comprehensive Plan shall remain in full force and effect.

SECTION 5. Effective Date.

The effective date of this Comprehensive Plan Amendment shall be: the date a Notice of Intent is issued by the Department of Economic Opportunity finding the amendment to be in compliance in accordance with Section 163.3184, F.S.; or the date a final order is issued by the Administration Commission finding the amendment to be in compliance in accordance with Section 163.3184, F.S. No development orders, development permits, or land uses dependent on this Amendment may be issued or commence before this amendment becomes effective.
