## NOTICE OF ADMINISTRATIVE HEARING

PLEASE TAKE NOTICE that at the date, time and place set forth below, a hearing regarding the condition of your property is scheduled before the Special Magistrate of the City of Parker. The purpose of the hearing is to review the Code Enforcement Officers determination of the above-referenced property as being a public nuisance.

- Hearing date/time: August 11, 2025, at 9:00 a.m. or as soon thereafter as the matter may be heard.
- Place: City Council Chambers, 1001 W. Park Street, Parker, Florida - Parker City Hall

At the scheduled hearing, you or your legal representative will be given the opportunity to present your own testimony or evidence or to cross-examine any witnesses. Your failure to attend the hearing referenced above shall constitute a waiver of your right to a hearing. Such waiver shall constitute an affirmation of the matters set forth in a possible Order and may result in additional remedies and/or penalties being assessed without the need for issuance of an additional notice that may include abatement by or on behalf of the City of Parker.

The hearing shall not be postponed or continued unless a written request for a continuance showing good cause for continuance is received by the undersigned at least 3 days before the date set for the hearing.

If you are a person with a disability who needs any accommodation in order to participate in this proceeding, you are entitled, at no cost to you, to the provision of certain assistance.
