

**CITY OF PARKER**

**REGULAR MEETING MINUTES**

**HELD AT 1001 W. PARK ST, AUGUST 5, 2025 – 5:30 PM**

**Approval of Minutes**

Moving forward with the item, a motion was made to approve the surplus items by Councilmember Barrow; seconded by Councilmember Bodiford. The motion was carried with all voting in favor; 5-0.

Councilmember Chaple shared details regarding the yard sale and the pig roast.


Councilmember Haney presented concerns and shared discussion regarding parking issues at Peet Park and the boat launch.
