Resident Pat Fousek clarified a previous comment and apologized to Ms. Kennon.

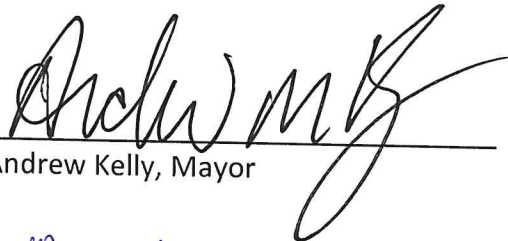
Resident Jeanette Howard inquired about having a meeting once CRA is received.

With no further discussion the meeting adjourned at 5:35 P.M.

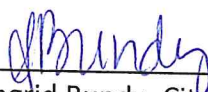
