Temporary RV Permit

Per Section 5-12.3 Additional regulation of Recreational Vehicles:

The following shall apply outside of a recreation vehicle park.

- 1. A temporary permit may be issued by the City Clerk to park or maintain a recreational vehicle other than as provided in this subsection 5-12.3 under the following conditions:
 - a. A permit shall be temporary, not to exceed a period of one year and the applicant for such permit shall pay to the City Clerk a municipal service charge in the amount \$120.00 for a one-year term, that the permit is to remain in effect.
 - b. A permit shall be renewable and shall be subject to revocation at any time that the City Clerk, in the City Clerk's discretion, determines that the conditions under which it was issued have materially changed or that revocation is required to protect the health, safety or welfare of the citizens of the City.
 - d. A permit may be granted only where the City Clerk determines that such permit is in the best interest of the City and:
 - i. The recreational vehicle is to be occupied, rent free, by a blood relative, within the second degree of consanguinity, of a person, or the spouse of a person, who owns and occupies a single-family dwelling on the parcel of land on which the recreational vehicle is to be placed; or
 - ii. The recreational vehicle is to be used exclusively as an office during a construction project; or
 - iii. The recreational vehicle is to be occupied as a residence during the period of construction, under an existing building permit, of a home by the applicant on a parcel of land owned by the applicant; or
 - iv. No significant harm to the interests of adjoining and nearby landowners will result if such permit is granted and special circumstances exist which will result in undue hardship to the applicant if such permit is not granted.
 - e. Notwithstanding the remainder of this subsection and without public hearing, the City Council may allow a recreational vehicle to be occupied for a limited amount of time as determined by the City Council following damage caused by a declared emergency if the recreational vehicle is to be occupied as a residence during the period of repair or construction, under an existing building permit, of a home by the applicant on the same parcel of land owned by the applicant. In the event that such repair of construction is as a result of a declared emergency, the fee may be waived by the City Council.
